Terms and Conditions of Participation in Beta Testing

ODOFIN™ Sniff-App

The participants understand and agree that participation in the Beta Program is voluntary and does not create a legal partnership, agency or working relationship between you and Burghart Messtechnik GmbH ("BMT"). BMT reserves the right to revoke participation in this Beta Test at any time. If BMT makes any changes to the terms of these Terms of Participation, the revised terms will be provided to participants.

Use of the Software. For the beta test, the software will be made available to participants for download.

The software is to be used only for its intended purpose. At the end of the 3-month trial period, the software will be automatically deactivated. It is not permitted to publish or pass on to third parties the software or other materials provided by BMT in connection with participation in the beta test.
